

CHAPTER VIII

Museum Parking Area Excavation and Excavation North of Mound "W"

Two excavations by the Alabama Museum of National History were located in an area northwest of Mound P and west of Mound Q. During 1941 this area which had been projected as the parking area for the Museum building -- and which, incidentally, was never built -- was gridded and excavated by Maurice Goldsmith. Within the area staked off for the parking area was an earlier excavation which had been designated north of Mound "W" and excavated in 1934. Figure VIII-1 shows the extent and relationship of these two excavations. These excavations have been combined to form this chapter.

Museum Parking Area Excavation, 1941.

Figure VIII-1 illustrates the grid system and the areas excavated within the boundaries of the proposed museum parking area. The trenches north of the roadway -- that is from 0 00 to 2 00 -- were generally devoid of archaeological features, and no field map was made of these areas. The area south of the roadway -- from 2 50 to 3 50 and especially in the large central block of






Figure VIII-2. Detailed plan of Museum Parking Area excavation.

excavated area between these points -- bounded with archaeological features. Four complete structures, a number of "midden" areas, several firebasins and five burials were found in an area bounded by 2 25 to 3 05, L4 to L15. Most of these features are shown in figure VIII-2.

The four structures recovered in the Museum Parking Area excavation have been numbered S-1 through S-4.

Douglas McKenzie included these structures in his dissertation (1964) and in an article on Moundville Phase house forms (1964a). Structure S-1 corresponds to McKenzie's House 5 and 5a (1964:288, figure 127; 1964a:51, table 1); S-2 corresponds to his House 4 (1964:227, figure 126; 1964a:51, table 1); S-3 corresponds to his House 6 (1964:230, figure 128, 1964a:51, table 1), S-4 corresponds to his House 7 (1964:231, figure 129, 1964a:51, table 1). McKenzie erred, however, when he located these structures "north of Mound Q" (ibid.). They were in fact located due west of Mound Q.

Structure S-1, which McKenzie interpreted as two structures, was a complex subrectangular structure located in squares 2 75 to 3 00, L10 to L15. The lengths of the exterior walls which defined this structure were: northern, 15.9 feet; eastern, 16.2 feet; southern, 15.6 feet; western, 17.0 feet. The two interior walls measured 11.1 feet

(southern) and 12.7 feet (western). The floor area of the structure as a whole was 275 square feet; the floor area of the interior room (or structure) was 150 square feet. A single round firebasin (F-6), a small "midden" area and a number of post molds were recorded inside the confines of structure S-1. Whether or not structure S-1 was only one structure or was in fact two structures, separated in time, but with two walls in common cannot be resolved from the data at hand. However, there were several other structures at Moundville which have been interpreted here as having enclosed passageways around a central room. Perhaps structure S-1 belongs in this category as a single structure.

Structure S-2 was a small subrectangular building located in squares 2 50 to 2 70, L10 to L14. The lengths of the wall trenches which defined this structure were: northern 8.3 feet; eastern, 10.4 feet; southern (interior), 6.0 feet; southern (exterior), 5.0 feet; western (interior), 9.0 feet; western (exterior), 10.2 feet. The interior floor area of structure S-2 was 116 square feet. Firebasin F-10 and a number of post molds were the only features recorded inside structure S-2.

Structure S-3 was a subrectangular structure covering squares 2 60 to 2 80, L6 to L11. The dimensions of the

wall trenches which defined this structure were: northern (both segments), 12.0 feet; eastern, 10.9 feet; southern, 10.4 feet; western, 12.1 feet. The interior floor area of structure S-3 was 175 square feet. One burial (3007), three firebasins (F-7, F-8, F-9) and numerous post molds were recorded inside structure S-3.

Structure S-4 was a subrectangular structure located in squares 2 35 to 2 50, L5 to L9. The lengths of the wall trenches which defined this structure were: southern (exterior) 10.5 feet; southern (interior segment), 5.6 feet; eastern, 11.2 feet; southern, 11.2 feet; western 11.5 feet. The interior floor area of structure S-4 was 131 square feet. The only features found inside this structure were a large "midden" area and a number of post molds.

Eleven firebasins were recorded in the Museum Parking Lot excavation. These firebasins, their locations, associations, and dimensions are presented in table VIII-1.

In every excavation which he supervised, Maurice Goldsmith recorded the exact location of all artifacts, except pot sherds, which were found. For the Museum Parking Area excavation these artifacts, their location (by square number), their depth below the surface, their associations and their catalogue numbers are presented in Table VIII-2.

In addition to the artifacts in Table VIII-2 several other artifacts were found in the back-dirt piles. These artifacts included 34 broken greenstone celts, 15 pieces of worked stone, three pieces of miscellaneous flint, 5 shells, a piece of mica, and a pottery discoidal.

Five of the 18 burials recovered from the Museum Parking Area excavation are shown in figure VIII-2; the rest of the burials were found in the many feet of trenches throughout the remainder of the excavation. All 18 burials are described below. A guide to these burial descriptions precedes the descriptions proper.

Excavations North and Northwest of Mound "W", 1934.

Late in January 1934 the Alabama Museum of Natural History excavated a 100 feet by 125 feet plot of land on the "Griffen Estate." This area was at the time just outside the western boundary of the park. The location of this excavation, its division into north and northwest sections and its relation to the Museum Parking Area excavation are shown in figure VIII-1.

The field map kept for the excavation north and northwest of "W" was, in general, uninformative of particulars, yet it abounded in general information. This map showed that most of the burials were located in the section of the excavation designated north of "W" and that the only structure recovered (which was meticulously recorded) was in the section of the excavation designated northwest of "W". Also most of the unassociated artifacts recovered from this excavation came from the section labeled northwest of "W". No doubt these artifacts were in one way or another associated with the activities around the structure.

The structure discovered during the excavation was a complex subrectangular building, internally partitioned to yield what looked like three rooms. This structure, designated S-1, is shown in figure VIII-3. As can be seen

in this figure, the northern and eastern corners of the structure were closed and the western side of the structure was partially open. The northern wall trench, measured to the mid-point of the closed corner, was 18.5 feet long; the eastern wall trench, measured from mid-point to mid-point of the two closed corners, was 16.3 feet long; the exterior southern wall, measured from the mid-point of the eastern corner to its terminus, was 16.0 feet long. Just inside the exterior southern wall was another wall trench which measured 19.2 feet east-west and 4.0 feet north-south. Interior to the three-sided shell formed by these wall trenches were what seemed to be a series of partitions. There was also a complex wall trench pattern which closed off the western side of the structure. The floor area of this structure was approximately 320 square feet.

Five burials and four in situ artifacts were discovered inside structure 1. Burials NWW1820 and NWW1821 were disturbed, probably at the time the structure was constructed; burials NWW1819, NWW1829 and NWW1830 were extended burials and were probably interred during the time in which the structure was occupied.

An unfinished stone axe (57NWW), and a pottery effigy head (6NWW), although not associated with the burials, were found near the grave of burial NWW1829. A

bone awl (30NWW) was found near the center of the structure and a "pitted stone" (4NWW) was found in the northwest corner of the structure. The unassociated artifacts from the excavation north of "W" are given in Table VIII-3.

Although no structures were found in the section of the excavation designated north of "W", several firebasins, a couple of wall trenches and an unusual pair of post molas were found in addition to the burials. The post molds were found in addition to the burials. The post molds were unusual because they were side by side and because at the bottom of one was a mass of charred corn cobs (44NW), while at the bottom of the other was a mass of charred textiles (45NW).

Other than the artifacts found at the bottom of these two post molds and the artifacts associated with the burials, only four unassociated artifacts were found north of "W". These artifacts included a greenstone discoidal (13NW), a piece of another discoidal (49NW), a mass of green paint (50NW), and some charcoal (51NW).

The majority of the burials from the excavations as a whole came from the section north of "W". Furthermore, the burials from the section north of "W" were concentrated in the southwest quadrant of that excavation. These burials plus the burials from the section northwest of "W" are described below.
